Vendor Selection and Payment Procedure

1. Vendor Segregation

• There shall be separate vendors for material supply and service provision to ensure specialization and quality for Point No -1.

2. Payment Terms and Phases for Point No-1

- o Payment shall be released in five phases:
 - Phase 1: 40% of the total payment will be made after initial work commencement.
 - Phases 2-4: Subsequent payments shall be released progressively as per work completion milestones.
 - Phase 5 (Final Payment): The last instalment shall be paid only after quality inspection and approval by the concerned department.

3. Invoice Processing and Timelines

- o During the construction phase, payments shall be made within 2 working days after the submission of a valid invoice, under all conditions.
- o Any discrepancies in the invoice must be addressed immediately to avoid payment delays.

4. Quality Assurance and Compliance

- The quality of materials and services must comply with the agreed specifications during the RFQ.
- o Any deviations found during inspection may lead to penalties or withholding of payment until rectifications are made.



5. Vendor Performance Monitoring

- o Regular evaluation of vendors shall be conducted based on timeliness, quality, and adherence to contractual terms.
- Vendors failing to meet standards may be replaced or blacklisted from future projects.

- Ensure quality checks at each construction milestone.

Installation of Water Coolers (Aqua Connect Initiative)

- o Deliver and install water coolers at designated locations.
- Ensure proper plumbing and electrical connections.
- o Conduct trial runs and water quality testing before commissioning.

Implementation of the Gift Milk Programme

- o Identify and verify beneficiaries (underprivileged children and pregnant women).
- o Distribute milk at designated centers in collaboration with local authorities.
- o Maintain distribution logs for tracking impact and ensuring accountability.
